#### **Dear Members:**

This is a great time to be a member of North Jersey Federal Credit Union. First, we have exciting news about our computer system update. In order to better serve our members, we will be able to offer new products including: a mobile app that lets you bank anywhere, anytime, Popmoney which allows you to send or receive money through email or a text, and a new full color statement. This computer update also helps us to be more environmentally friendly and getting us closer to our goal of going paperless. Members will no longer have to use deposit tickets at the



branches. They just have to have their ATM/debit card or an ID and we'll take care of the rest. Although we love to see you, our updated system will make it easier to never walk into a branch again. Home Banking and Bill Pay will be more robust. Members will be able to apply for a loan and even open an account on-line. In order to do this, we will close the Credit Union during the weekend of April 1-3. ATMs will be available over the weekend. However, Home Banking, Shared Branching and TAP will not be available that weekend. We'll be back up and running on Monday, April 4th. Next, we are very proud to celebrate our 80th Anniversary this year. We started out as the Passaic County Teachers Credit Union and we now have over 30,000 members, serving Passaic, Bergen,



Our new service upgrades will include Popmoney®, a personal payment tool, improved Bill Pay, and the ability for you to see nearly real-time transactions through Home Banking.

We are also excited to announce our new mobile app. This will allow you to bank anywhere, anytime on your mobile device. With the mobile app, you can check account balances, transfer funds, pay bills, and locate an ATM.

Don't forget the Credit Union will be CLOSED on Friday, April 1 and Saturday, April 2, 2016.

We will reopen on Monday, April 4, 2016.

Here is what to expect during the upgrade:

- ATMs are available for cash withdrawals during the upgrade. To find the closest ATM near you, use the branch/ATM locator or visit any 7-Eleven Convenience Store.
- Remember Shared Branching will NOT be available during the upgrade, Friday, April 1st - Sunday, April 3rd, 2016.
- Home Banking, Bill Pay and Popmoney will not be available from March 31st, 6:00 p.m. - April 3rd. If you have previously scheduled payments during that time in Bill Pay, they will be paid and will be reflected in your account on Monday, April 4th.
- TAP (Telephone Account Processing) will not be available after
   6:00 pm on Thursday, March 31st Sunday, April 3rd, 2016.
