Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

How?	All financial companies need to share members' personal information to run their everyday business. Definitions				
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.			
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul> <li>Data/card processors, check printers, rewards program managers</li> </ul>			
Joint marketing	<ul> <li>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</li> <li>Our joint marketing partners can include insurance companies.</li> </ul>
